Agreement Pursuant To a co-Tutorial Joint Supervised Thesis For Diana Nekrasova

University Lille 1 and the Saint Petersburg state University aim to foster academic mobility of doctoral students with the aim of strengthening scientific cooperation in various fields of Earth Sciences including crystallography and catalysis and solid state chemistry.

In line with this, both educational organizations have agreed to on the basis set forth in this agreement conditions D. NEKRASOVA will conduct research and perform work on final qualifying work in St. Petersburg state University and PhD thesis at the University Lille 1.

In case of successful passing of intermediate certification in teaching at the basic educational program of the PhD programme and the state final attestation in St. Petersburg state University D. Nekrasova diploma of completion of postgraduate studies in accordance with the legislation of the Russian Federation and local acts of the Saint Petersburg state University. The text of the final qualification work performed by D. Nekrasova, can be used in the thesis in accordance with the legislation of the Russian Federation.

Upon successful defense of the thesis in the University of Lille 1 D. Nekrasova will be awarded the degree of doctor of the University Lille 1.

The two Parties have drawn up and agreed on the following measures:

No communication and/or publication of a scientific and/or technical nature, relative to the research and/or the results achieved and obtained within the framework of the collaboration project may be decided by one Party without the express agreement of the other. Such communication will make specific reference to the existing partnership.

With regard to any secret material, the two parties agree to ensure that confidentiality respected by their personnel.

The legal rights regarding any inventions developed by each team in their own right remain the property of the Party responsible.

Any inventions developed as a result of work carried out jointly by the research teams in the laboratories concerned, should they be liable to protection, will be subject to protection as decided by mutual agreement (secret status, patenting application made in joint name of parties concerned, etc.)

Co-tutorial convention - Lille 1 -

Each party agrees to respect the regulations in force relative to the rights and obligations of the inventors in accordance with the customary regulations and practices in such cases.

Article VII Annulment of the present agreement

Should one of the two partner institutions consider that the quality of the research is not appropriate, or in case of failure to comply with the obligations laid down in one or several articles of this agreement, one or other of the parties is at liberty to terminate the present agreement. In such a case, notice of termination of the agreement must be made at least 6 months before the beginning of each academic year.

Article VIII Duration

The present agreement is entered into for the time necessary to completion of the thesis of Miss D. NEKRASOVA. At the end of this period, the provisions laid out in Article VI will remain in effect until the thesis has been defended and for a period of one year following this date.
