Extension Agreement

of the Double Degree programmes (M.Sc.)

„Business Informatics“ and „Information Business Analytics“

between the

Department of Economic Sciences and Media

Technische Universität Ilmenau, Germany

Represented by its President Prof. Dr. Kai-Uwe Sattler

and the

Saint Petersburg University, Russia

Represented by its Vice-Rector for International Affairs Sergey Andryushin

1. The partners agree on the extension of the Cooperation agreement of the Double Degree Programmes (M.Sc.) „Business Informatics“ and „Information Business Analytics“ of April 30th 2015 (hereinafter referred to as „the agreement“) based on the cooperation agreement between Technische Universität Ilmenau (hereinafter referred to as TU IL) and Saint Petersburg University (hereinafter referred to as SPbU) dated from June 29th 1995.
2. The phrase „in the network form“ („в сетевой форме“ – in the Russian version of the agreement) shall be excluded from the name and the further text of the agreement due to the latest changes in the Russian legislation in the field of education.
3. In paragraph 2 number 2.2 of the agreement the last sentence is deleted.
4. In paragraph 2 of the agreement number 2.4. is newly worded as follows: "Students of SPbU, who study in the " Information Business Analytics " course of studies at SPbU, wish to study at TU IL in the "Business Informatics" course of studies and are selected in the procedure according to Paragraph 5 and have been sent by SPbU, will be enrolled at TU IL in the course of studies "Business Informatics" according to the rules applicable at TU IL."
5. In paragraph 5:
 - 5.1. number 5.2 of the agreement the last sentence is newly worded as follows:

“To the selection process for enrollment in the university partner program students are admitted who are enrolled in the first semester of the "Business Informatics" course of studies at TU IL or in the " Information Business Analytics " course of studies at SPbU and



prove German or Russian language skills in accordance to the applicable regulations of the respective host university."

5.2.number 5.3. of the agreement shall be excluded; number 5.1. shall be considered as prevailing.

6. In paragraph 6 number 6.3 of the agreement the following sentence has to be added:

"SPbU students studying at TU IL undertake to complete the part of SPbU's educational program implemented during the third semester of study (6 ECTS) during the fourth semester of study at SPbU based on an individual study plan."

7. In paragraph 8 of the agreement an additional number – 8.4. - is added:

"Students will pay academic tuition and fees to their home institution and will receive tuition waivers from the host institution. They will not be charged for admission fees, tuition or any other charges related to the host institution. Extracurricular fees, e.g. sport and language course fees or administrative fees can be charged by both universities and are subject to the legal requirements of the respective Universities. Exchange students admitted to TU IL will pay a "Semester Contribution" ("Semesterbeitrag") of about 150 €, which is valid at the time of the enrollment as an exchange student at TU IL. This is not a university fee, but a charge destined for a national student organization that includes a train pass, the use of the sport complex, access to meals and housing discounts, and other social and cultural services.

8. This extension agreement constitutes the period validity for seven years as of the date signed in this agreement.

9. This document has been printed in two (2) identical copies; each party retains one copy of this agreement. In witness of the terms of the agreement, and intending to be legally bound, signatures of the following authorized representatives of the parties are affixed.
